Overall outcome

The school is likely to meet the relevant independent school standards if the material change relating to the school provision is implemented

Main inspection findings

Part 2. Spiritual, moral, social and cultural development of pupils

Paragraphs 5–5(d)(iii)

- The promotion of pupils' spiritual, moral, social and cultural (SMSC) development plays a central role in school life. The school's SMSC curriculum is underpinned by a commercial personal, social and health education (PSHE) programme, which provides a secure framework for teaching. Leaders have given careful thought to how and when different aspects of this programme are taught, to ensure it is appropriate and meaningful. The programme includes content relevant to the increase in age range proposed.
- Leaders have extended the breadth of the curriculum since the last standard inspection. This has enriched learning with further opportunities for pupils to study English literature, history, drama and art. The school provides a range of extracurricular activities, such as a music club and an information technology club, which support pupils' engagement and help to make learning meaningful.
- Assemblies and community meetings are a key feature of school life. They are used to promote aspects of SMSC such as fundamental British values, to consider different beliefs, and to celebrate achievements. Pupils have regular opportunities to consider and discuss current affairs and thought-provoking issues, such as the war in Ukraine and the experiences and perceptions of refugees.
- Pupils are expected to behave well and to be kind to each other. Special events such as 'Kindness Week' encourage them to think about the contribution they can make to the school and the wider community.
- The school's extensive grounds include mature gardens, lawned areas, an outdoor gym and a forest school. They provide an attractive and peaceful setting for school life. Pupils use facilities such as the outdoor gym, table tennis and dipping pond regularly. Activities such as these make a valuable contribution to pupils' social, spiritual and personal development and to their enjoyment of school.



■ The school is likely to meet the requirements in this part of the standards if the proposed material change is agreed.

Part 3. Welfare, health and safety of pupils

Paragraphs 7–7(b), 11–12, 14, 16(a)–16(b), 32(1)(c)

- The school's safeguarding policy complies with current statutory guidance. It provides a comprehensive range of information, including the names and contact details for the designated safeguarding leads (DSLs). The policy is published on the school's website.
- Well-established safeguarding procedures ensure that the school runs smoothly and operates safely. Leaders take suitable steps to keep staff informed of safeguarding updates, such as daily briefings, regular training and weekly updates from the headteacher.
- The school uses a centralised record system to log and monitor any safeguarding concerns. Members of the safeguarding team maintain a careful overview of any concerns, actions taken and progress made. The DSLs work closely with agencies such as children's services and the police, as appropriate.
- Pupils are well supervised throughout the school day. Suitable arrangements have been made to ensure this continues to be the case if the proposed change is approved.
- The proprietor ensures the school's continuing compliance with fire safety legislation. Leaders maintain robust procedures to ensure that all checks and services on fire safety equipment are completed in a timely manner. A recent external audit of fire safety arrangements identified a few minor remedial actions required. All have been addressed.
- The school is likely to meet the requirements in this part of the standards if the proposed material change is agreed.

Part 4. Suitability of staff, supply staff, and proprietors

Paragraphs 18(2)–18(e), 18(3), 19(2)–19(2)(d)(ii), 19(3), 20(6)–20(6)(c), 21(1)–21(7)(b)

- The single central record meets statutory requirements. Robust procedures ensure that recruitment and suitability checks are completed appropriately.
- Leaders have increased the number of pupils on roll gradually since the school opened and intend this to be the case in the coming months. This means that the proposed material change is unlikely to require an increase in staffing in the short term. Several current members of staff have experience and expertise relevant to teaching and supporting pupils in the proposed age range.
- The school is likely to meet the requirements in this part of the standards if the proposed material change is agreed.

Part 5. Premises of and accommodation at schools

Paragraphs 23(1)-23(2), 24(1)-24(1)(b), 24(2), 25-29(1)(b)

■ The school provides well-equipped accommodation, which is maintained to a high standard. The school's existing accommodation includes a range of specialist teaching

rooms, such as a food technology room and an art room, which are suitable for delivery of the curriculum for the increased age range proposed. Existing accommodation also provides welcoming areas for pupils to use for relaxing and socialising.

- The school's medical room is appropriately equipped for purpose, including a bed, lockable cupboards and a fridge. Toilets are conveniently located next to the medical room.
- The school's outdoor areas are well maintained. Pupils have access to a range of high-quality equipment during the day, such as a trim trail, picnic tables and football goals.
- The school is likely to meet the requirements in this part of the standards if the proposed material change is agreed.

Part 8. Quality of leadership in and management of schools

Paragraph 34(1)-34(2)

- Leaders are highly knowledgeable about teaching pupils with special educational needs and/or disabilities. They maintain reliable procedures which ensure that the independent school standards continue to be met.
- The chief executive officer has taken the decision to apply for an increase in age range following direct requests from pupils. The rationale for the change is based firmly on pupils' educational and personal development needs. Leaders are confident about the contribution the school can make to pupils' ongoing engagement with education and to preparing them for future lives.
- The school is likely to meet the requirements in this part of the standards if the proposed material change is agreed.

■ Leaders and staff are committed to ensuring compliance with the Equality Act 2010. Equality of access lies at the heart of the school's work. The curriculum promotes tolerance and respect for people from a range of backgrounds, contexts and beliefs, with close attention given to those with protected characteristics.

- ISP School Battle is a special school providing education for pupils with social, emotional and mental health difficulties, as well as communication and interaction, and cognition and learning needs. Pupils may well have associated conditions such as autism spectrum disorder and/or sensory or physical needs.
- All pupils are placed by local authorities and have education, health and care plans. Many have been out of education for long periods before joining the school.
- The school's first standard inspection took place in November 2022.
- The school does not currently use alternative provision.
